## **APPLICATION: BPSC RANGE KEYS 2024**

#### **BACKGROUND**

BPSC obtained its NRCS accreditation on 25 February 2021. This certificate confirms that BPSC complies with all the safety rules and regulations of South Africa for an outdoor shooting range. BPSC applied for SAPS accreditation in December 2021 and restarted this application again on 6 December 2023. The SAPS visited the range on 15 January 2024 to do an inspection. To comply with their requirements, the following must be in place:

- BPSC key application process;
- Kev register;
- Monitoring and logging the range's access, entry, and exit for all persons (members and visitors).

The EXCO of BPSC already approved the "shooting range key criteria application process" on 15 January 2020. These criteria were never strictly enforced, but we have no choice but to put the application process in place due to the above reasons. The gate locks will be replaced at random intervals to reduce unauthorised access to the shooting range.

**Note** that this is not a wild goose chase of the EXCO to take back any person's key. This process must be implemented to protect BPSC and its club members and to help ensure that NO unauthorised persons are using the range.

#### **APPLICATION PROCESS**

BPSC members (with a minimum membership of two years) and organisations that signed an MoU with BPSC can complete the application form below and send the document electronically to <a href="mailto:info@bpsc.co.za">info@bpsc.co.za</a>. The EXCO of BPSC will consider all applications.

## COSTS

There will be no cost for members who currently have a set of keys. A fee will be charged in the following situations:

- New key applicants;
- Replacement keys when keys go missing.

## **GENERAL**

All of the issued keys will be marked with a unique number before they are issued. This will allow the EXCO of BPSC to keep track of the issued keys. Keyholders are not allowed to make copies of keys.
